- 10) The approved transaction shall be incorporated in day –ahead scheduling in accordance with the provisions of TNERC Grid Connectivity and Intra State Open Access Regulations-2014.
- 11) The approval is subject to provisions of TNERC Grid Connectivity and Intra State Open Access Regulations, 2014 and any other relevant Regulation/Order/Code as amended and applicable from time to time.
- 12) In addition to the above, the captive users shall abide by the terms and conditions vide Annexure.
- 13) The open access charges shall be collected from Generator at SE/EDC/Mettur, instead of SLDC before the commencement of open access, until TANTRANSCO become full fledged entity with sufficient staff and infrastructures.
- 14) At any point of time, if the generator fails to maintain the CGP status and the consumer is proved to be the non captive user of that CGP, then the power availed as captive user during the entire period of open access transaction will be treated as third party transaction and will attract cross subsidy surcharge.
- 15) The above approval is Subject to make corrections according to TNERC Tariff order dated 11.08.2017.
