- 13) The open access charges shall be collected from Generator at SE/EDC/Nagapattinam, instead of SLDC before the commencement of open access, until TANTRANSCO become full fledged entity with sufficient staff and infrastructures.
- 14) At any point of time, if the generator fails to maintain the CGP status and the consumer is proved to be the non captive user of that CGP, then the power availed as captive user during the entire period of open access transaction will be treated as third party transaction and will attract cross subsidy surcharge.
- 15) The above approval is Subject to make corrections according to TNERC Tariff order dated 11.08.2017.
