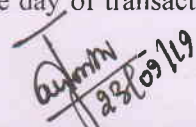

It is hereby certified that:

- We have “No Objection” to seeking and availing Open Access by **OPG Energy Pvt Ltd**, through Power Exchange upto the MW ceiling as specified above, in accordance with applicable regulations of **CERC/TNERC**.
- We have the required infrastructure for energy metering and time block wise accounting in place. The State/ Distribution licensee network has the required transfer capability for transfer of power as per specified ceiling.
- The Transmission Charges for the use of State/Distribution Licensee network and Operating Charges for the State Load Despatch Centers shall be directly settled by Power Exchange with us.
- The State Utility designated for the purpose of collection/disbursement of UI charges shall be responsible for timely payment of State’s composite dues into the Regional Pool Account.
- Any mismatch between the Scheduled and Actual drawal/injection for the intra-State Entity shall be determined by us and will be covered in the intra-State UI accounting scheme, or as applicable.
- The Reactive Energy Charges shall be governed by the Regulations applicable within the State.
- We shall disburse the Transmission Charges for use of the State/Distribution Licensee Network to the State Transmission Utility /Distribution Licensee directly.
- We shall inform the total import and export capability of the State as a whole to all concerned. Attempt shall be made to declare this in advance through our website.
- Any change in the contents of the Standing Clearance/NOC shall be conveyed to the party to whom Standing Clearance/NOC was given, latest by 10 Hrs. of the day prior to the day of transaction. In such cases, the Power Exchange(s) shall also be informed simultaneously.
