- 12) The approved transaction shall be incorporated in day –ahead scheduling in accordance with the provisions of TNERC Grid Connectivity and Intra State Open Access Regulations- 2014.
- 13) This approval is subject to provisions of short term power purchase of Tender No 22 of 2022.
- 14) As per the Schedule of payment enclosed, the short-term open access customer shall deposit with SLDC the transmission charges, Wheeling charges (If Applicable) and SLDC charges for the entire period of open access within three working days of grant of the short- term open access by SLDC, but before the commencement of open access.
- 15) The Quantum committed vide LOA to TANGEDCO may be maintained irrespective of the already committed Quantum vide Inprinciple approval dt.25.02.2022 by making necessary arrangements which has also been undertaken by the Generator. The generator is also requested to adhere the clause 12(2) of the TNERC's Grid Connectivity and Intra-State Open Access Regulations, 2014, the generator has submitted the undertaking by the captive users for not having entered into power purchase agreement (PPA) or any other bilateral agreement with more than one person for the same quantum of power for which open access is sought.
