- 10) The approved transaction shall be incorporated in day –ahead scheduling in accordance with the provisions of TNERC Grid Connectivity and Intra State Open Access Regulations-2014.
- 11) The approval is subject to provisions of TNERC Grid Connectivity and Intra State Open Access Regulations, 2014 and any other relevant Regulation/Order/Code as amended and applicable from time to time.
- 12) In addition to the above, the thirdparty users shall abide by the terms and conditions vide Annexure.
- 13) As per the Schedule of payment enclosed, the short-term open access customer shall deposit with SLDC the transmission charges and SLDC charges for the entire period of open access within three working days of grant of the short- term open access by SLDC, but before the commencement of open access.
- 14) **Cross subsidy surcharge determined on Per Unit basis shall be payable on monthly basis, by the open access customers based on the actual energy drawn during the month through open access.**

Note: This Generator is under REC Scheme, hence Energy wheeling Agreement under REC scheme to be executed to confirm that the generators are not availing any benefit in the form of concessional/promotional transmission or wheeling charges or banking facility benefit.

The transmission charges shall be collected for the approved STOA quantum and the quantum of allotment to the HT consumers shall be after deducting the line loss component.

Annexure

Standard Terms and Conditions.

1. The quantum of power to be purchased by the HT consumer both inter state (collective transaction and bilateral transaction) and intra state open access transactions together shall not exceed their sanctioned demand at any time.
2. The HT Consumers can use the purchased power only up to their sanctioned demand.
3. The company have to pay the applicable charges as per prevailing TNERC Orders and regulations in force.
4. Any additional charges that may be approved by TNERC at a later date and any waived charges by TANTRANSCO/TANGEDCO shall also be leviable, with retrospective effect or from the date as approved by TNERC or TANTRANSCO/TANGEDCO respectively.
5. The Generator shall give necessary day ahead schedule of the generation and wheeling quantum to HT consumers, concerned SE's Distribution Circles of HT consumers & Generator and SLDC.
6. The HT consumer shall draw the power according to their schedule only.
7. The company shall have to backdown/shutdown their generation/Generator as per SLDC instructions for which they are not eligible for any compensation and it is the responsibility of the generator to intimate their HT consumers and concerned SE/EDCs regarding their outage of plant or lesser/Nil supply of committed power by giving due schedules. Accordingly the HT consumers shall reduce their drawal.
8. The Wheeled power scheduled at ex-periphery of the Generator shall be subjected to deduction of TANTRANSCO's/TANGEDCO's Transmission and distribution losses stipulated in TNERC Orders.
9. If the HT consumer does not draw the committed power due to any reasons, the generator / HT consumer will not be compensated by TANGEDCO.
10. Lesser/nil drawal due to Demand side management in order to maintain grid security, feeder tripping on protection break down and grid constraint shall not be compensated.

11. The billing and energy accounting shall be done on monthly basis. Based on the Open access approvals and schedules, the concerned SE/EDC of the generator shall allocate slot wise , HT consumer wise energy to the concerned SE/EDC of the HT consumers. Accordingly the energy shall be adjusted slot wise on first charge basis from their monthly consumption.
12. Issues related to Energy accounting towards generation, their own use, the HT consumers use, Penal measures and any other disputes arising in the above shall be sorted out and resolved at EDC and Regional level.
13. In case of violation of any terms and conditions and/or non-payment of any of the charges payable, the open access approval will automatically get terminated and for restoration, TNERC have to be approached.
14. The consumer shall adhere to the various provisions of Electricity Act 2003, Electricity Rules 2005, Grid connectivity and Intra-state Open Access regulations 2014 and prevailing TNERC Orders and their amendments issued from time to time.
15. The permitted open access customer shall furnish an undertaking to the effect that the company will strictly adhere to the terms and conditions specified and indemnify TANGEDCO/TANTRANSCO for any loss or damage suffered by it by allowing wheeling under open access.
16. If the consumer draws power from the grid beyond approved open access period, necessary penal measures shall be applicable as per prevailing TNERC regulations and orders.
17. These conditions are in addition to the other conditions as stipulated in TNERC regulations and orders in force.
- 18. For Consumers less than 1 MW , approval is accorded subject to direction based on G.O.No.37. dated 17.04.18.**
