**Annexure –I**

**Terms and Condition for Thirdparty Energy wheeling approval**

1. The generator shall execute an Energy Wheeling Agreement (EWA) with the SE/EDC concerned for the approved period.
2. The company shall furnish applications under STOA till the transaction is commenced under MTOA.
3. The company shall not inject any power in to the grid without valid open access approval.
4. Any energy injected into the grid over and above the agreed contracted quantum shall not be accounted.
5. The approved open access quantum may either be cancelled (or) revised downwards subject to provision of Grid connectivity& ISOA Regulation - 2014.
6. The company shall adhere to the various provisions of Electricity Act, 2003, Electricity Rules 2005, required metering provisions as per CEA regulations 2006 and subsequent amendments and prevailing TNERC Intra-state Open Access regulations & Orders.
7. The company shall have to backdown/shutdown their generation/Generator as per SLDC instructions for which they are not eligible for any compensation and it is the responsibility of the generator to intimate their HT consumers and concerned SE/EDCs regarding their outage of plant or lesser/Nil supply of committed power by giving due schedules. Accordingly the HT consumers shall reduce their drawal.
8. The company shall not claim any compensation for any difficulties arising in due to outage, breakdown of the transmission system and for constraints in the grid.
9. If the HT consumer does not draw the committed power due to any reasons, the generator / HT consumer will not be compensated by TANGEDCO.
10. The company shall have to back down/shutdown their generation/Generator as per SLDC instructions for which no compensation is eligible and it is the responsibility of the generator and concerned SE/EDCs regarding their outage of plant or lesser supply of committed power by giving due schedules.
11. Lesser/non-drawal due to demand side management in order to maintain grid security, feeder tripping on protection, break down and grid constraints shall not be compensated.
12. Issues related to Energy accounting towards generation, their own use, the HT consumers use, Penal measures and any other disputes arising in the above shall be sorted out and resolved at EDC and Regional level.
13. 12. For Consumers less than 1 MW , approval is accorded subject to direction based on G.O.No.37.
