The DSM Pool Statement for the week from 12.08.2024 to 18.08.2024 is enclosed herewith along with Day Wise DSM statement of DSM charges computed in accordance with the TNERC (Deviation Settlement Mechanism and Related Matters) Regulations 2019 and its Procedure approved by Hon'ble TNERC on 03.10.2020.

As per TNERC Order No.1 of 2024, Commercial Operation of Deviation Settlement Mechanism (DSM) has been commenced from 01.04.2024 for the Intra-State Generators.

Further, as per TNERC Order dated 13.08.2024, the Cap rates (303.04 paise per KWh for all the Open access generators and private generators and 311 paise per KWh for the generators whose tariff is determined by commission) prescribed in the DSM Regulations 10(A)(2) & 10(A)(3) are removed and will also be removed for subsequent weeks.
