Subject: State Deviation Settlement Account (Deviation charges) for the week from 16.06.2025 to 22.06.2025 (Week No.12, Revision 0)

Sir,

As per TNERC Order No.1 of 2024, Commercial Operation of Deviation Settlement Mechanism (DSM) has been commenced from 01.04.2024 for the Intra-State Generators.

The DSM Pool Statement for the week from 16.06.2025 to 22.06.2025 is enclosed here with along with Day Wise DSM statement of DSM charges computed in accordance with the TNERC (Deviation Settlement Mechanism and Related Matters) Regulations 2019, its Procedure approved by Hon'ble TNERC on 03.10.2020, its Amendment Regulations 2024 and TNERC MP22 Order dated 13.08.2024

The Cap rate for both Private and State-owned Generators has been removed in present DSM statement. However, the penalty charges towards Sign change violation in Regulations 10(A)(1), 11(A) and 11(Q), Percentage (%) limit for excess of total Schedule in Regulations 11 (A), Frequency band in Regulations (7)(1)(C) and New price vector for Deviation Charges in Annexure I & III of Regulations shall be calculated under revised DSM statements commencing from 22.01.2025 and will be published later as per TNERC (Deviation Settlement Mechanism and Related Matters) (Amendment) Regulations 2024, "If payments against the Charges for Deviation including Additional Charges for Deviation are delayed by more than two days, i.e., beyond twelve (12) days from the date of issue of the statement by the SLDC, the defaulting constituent shall have to pay simple interest @ 0.06% for each day of delay and the same may be added in the energy bill.
