- a. Given the criticality of the Deviation Settlement Mechanism, Commission hereby extend the time up to 31-12-2025 in implementing the Regulations 7(1)(c), 10(A)(1), 11(A), 11(M), 11(N), 11(Q), Annexure-I, Annexure-III and the change of lower limit of frequency from 49.85 Hz to 49.90 Hz as stipulated under “General Amendments” in the Tamil Nadu Electricity Regulatory Commission (Deviation settlement mechanism and related matters) (Amendment) Regulations, 2024 notified by the Commission vide Notification No. TNERC/DSM&RM/22-3, dated 27-12-2024 and the commercial impact of the above portions of Regulations shall come into effect from 01.01.2026. No more extension of time limit will be permitted by the Commission.

- b. The petitioner shall file monthly progress report on various aspects such as readiness of software, data transfer from the generator/consumer end, communication issue, etc. to the Commission on or before 10th of every month up to the month of December, 2025.
